The Responsible Person acknowledges and understands the increased risk to their invitees and guests of exposure to COVID-19 and will take all necessary steps to ensure compliance with current NSW Government guidelines for additional availability of hand sanitiser and social distancing best practice at the Function.
7.	The Responsible Person acknowledges that the current situation could change at short notice with the introduction by the NSW Government of more stringent attendance limits which may result in the cancellation or further reduction of numbers of attendees of any function planned to be conducted in the Thirroul Surf Lifesaving Club Function Centre.
8.	The Responsible Person acknowledges that the Board of Directors of Thirroul Surf Lifesaving Club may give notice to the Hirer that the function may be cancelled at any time prior to the commencement of the function with very little notice, although the Board of Directors of Thirroul Surf Lifesaving Club will endeavour to provide as much notice as possible if cancellation of the function is required due to any change in the current NSW Government directions.
9.	The parties agree that any deposit paid by the Hirer to the Thirroul Surf Lifesaving Club will be refunded, subject to any costs that may have been incurred by the Thirroul Surf Lifesaving Club being deducted.
10.	The Hirer forever indemnifies the Thirroul Surf Lifesaving Club, its Directors and members from and against all claims, demands, writs, summons, actions, suits, proceedings, judgements, orders, decrees, costs, losses and expenses of any nature whatsoever arising from any cancellation of the Function or termination of the hiring agreement by the Directors or members of the Thirroul Surf Lifesaving Club or any incident including any person contracting COVID-19 from within the Thirroul Surf Club Function Centre as a result of attending the function.
